

SIBLING SELF-TRANSPORTATION AGREEMENT
Administrative Procedure 602: Transportation of Students by Private Vehicle

Policy Statement

Students shall not be permitted to transport other students in a private vehicle to or from any school sponsored or school related activity, except where the parents/guardians of siblings participating in the same activity have completed a Sibling Self-Transportation Agreement on file with the Principal.

This agreement applies only to siblings who are both participating in the same school sponsored or school related activity. It permits one sibling to transport another sibling to or from that activity in a private vehicle, with the written consent of both families and subject to the conditions set out below. This form must be completed and on file with the Principal before any sibling self-transportation occurs.

Section 4: Conditions of This Agreement

1. This agreement applies only to the activity, dates, and route identified in Section 1, and does not extend to any other activity or occasion.
2. Both the parent or guardian of the driving sibling and the parent or guardian of the passenger sibling must sign this agreement prior to the activity.
3. The driving sibling must hold a valid driver's license appropriate to the vehicle being operated. A driver holding a Graduated Driver's License (GDL) shall not be permitted to transport students.
4. Passenger loads, including the driver, shall not exceed the insured passenger capacity of the vehicle and shall not exceed limits permitted by law and by insurance for the specific vehicle involved.
5. Any damage to the vehicle, including the owner's vehicle, is the responsibility of the vehicle owner and not the Division.
6. This agreement does not transfer any liability to the school or the Division for the transportation arrangement described above.
7. A completed copy of this agreement must be on file with the Principal before sibling self-transportation occurs.

Section 5: Acknowledgement and Signatures

By signing below, the parents or guardians of both the driving sibling and the passenger sibling acknowledge that they have read and understood the conditions of this agreement and Administrative Procedure 602, and consent to the sibling self-transportation arrangement described above.
