- An Inclusive Education report was provided for the Board Members to review.

IX. <u>Secretary-Treasurer's Report</u>

- In the Provincial Budget, the funding rates are unchanged from 2016-2017. However senior high funding is maxed to 45 CEUs. Last year students could earn up to 60 CEUs and we were paid for the lesser of the CEU earned and 60 CEU. We are currently looking at what the schools generated for CEUs.
- The government has changed the Plant Operation and Maintenance grant. They provided grant estimates for 2017-2018, however they did not reduce the calculations of the online students. The net plant operation grant will be higher next year based on the Small School by Necessity grant.
- The 2016-2017 reports are up to date with the school generate funds. All the data has been summarized for February and entered into the system.
- Secretary-Treasurer is currently working with SRB on the electronic expense claim. It will roll it out next week.
- The leave management will be rolled out about April 10. Training needs to be provided for
 the secretaries and principals. Everything will be tracked and if there is leave without pay it
 will be sent to payroll so it can be deducted from their pay. Once leave is logged, a
 replacement substitute teacher is scheduled.
- Schedule entry web requires a schedule to be entered into the system.
- Time entry web implementation is just starting and should be finished by June 24.
- The HR staff in Central Office had 14 hours of webinar training in leave management.
- KEV has been rolled out to the parents in the division so parents can now pay online.
- There was election training on December 2 put on by ASOBA however the Secretary-Treasurer was not able to attend.

The Board accepts the Secretary-Treasurer's report as presented.

X. Assistant Superintendent's Report

- The Assistant Superintendent is in the middle of the data and goals meetings with the Principals. So far he has visited Christ-King School, St. Jerome's School, Blessed Sacrament School, and St. Thomas Aquinas School tomorrow.
- The Assistant Superintendent has had a discussion with the youth minister about moving forward.

- The Assistant Superintendent had a discussion with Alberta Education Finance regarding three students from Poland. Finance said that those students would be funded as Alberta students if they get their study permit because they are a step child of a Canadian Citizen.
- The Assistant Superintendent has been working with Teledata to fix some issues with St. Jerome's School.
- The Assistant Superintendent has met with all the school councils except for St. Jerome's School.
- The next Wellness meeting is on April 28, 2016. It will be held at the Communiplex. The students will be organizing and chairing the meeting.

The Board accepts the Assistant Superintendent's report as presented.

XI. Superintendent's Report

- The Secretary Treasurer has explained the impact of the budget as much as we know it now.
- The Assistant Superintendent and Superintendent attended the latest CASS session.
- The Assistant Superintendent and Superintendent attended a session with the School of Hope parents in Edmonton this month.
- Alberta Education met with School of Hope as part of their review of online schools throughout the Province.
- Interviews will be held for the Principal positions at St. Thomas Aquinas School and Christ-King School.
- Trustee J. Sanson and Superintendent McCormack provided supper for the St. Jerome's School staff to say thank you for their patience during the modernization.
- The Assistant Superintendent, Secretary-Treasurer and Superintendent watched a session on solar energy.

XII. <u>Committees</u>

ASBA Representative - Trustee D. Klein

• Trustee D. Klein informed the board members that Saskatchewan will leave the school boards as being elective. There is a Rural Cacaus that is speaking with one voice but there are different needs in places. There was a discussion on student teachers and an overabundance of biology and chemistry teachers. It was mention that they should send them to rural Alberta but a comment was made that there was no housing accommodations for them. The Professional Development this month was on the effects of pornography on children. They were shown a video that went through how a 9 year old became addicted to pornography and the effect that it had on the child and family. The video can be purchased for \$180. They also had Professional Development on eating disorders which went through all of the different types of eating disorders that people are dealing with.

- ACSTA is currently reviewing their vision statement and they are looking for feedback from the school boards. Any responses from school boards need to be received by mid-April.
