

General Requirements:

All schools and central services shall have the appropriate first aid supplies and trained staff to support an ill or injured personal until complete medical care and treatment can be administered. The minimum first aid requirements shall be based on the approximate number of staff, students and volunteers on the premises at each location. Minimum first aid requirements can be found in the OHS Program Manual or the OHS Act, Regulation and Code (Table 6).

Decision unit administrators shall-

- Provide a designated area for the provision of first aid services and supplies if there are more than 99 people located at the worksite;
- Ensure that all staff and building occupants are informed of the location of first aid supplies and trained personnel through the posting of signage and/or other means such as written documents or verbal instruction; and
- Cover all costs associated with first aid services, training and supplies.

FIRST AID TRAINING AND SUPPLIES

Decision unit administrators shall ensure:

- First aid training is delivered by certified instructors and that selected courses have been approved by the Alberta Government. (e.g. St. Johns);
- First aid training certificates are kept current and renewed every three years;
- The appropriate type and number of first aid kits and supplies required for their location are readily accessible during all working hours and are adequately maintained;
- First aid kits do not contain prescription or non-prescription drugs;
- Emergency eyewash equipment is provided in areas where corrosive chemicals harmful to the skin or eyes are used; and
- If a person with a serious injury or illness is transported to a medical facility by means other than an ambulance, that the injured person is accompanied by at least one trained first aider other than the operator of the vehicle.

FIRST AID RECORDS AND REPORTING

Decision unit administrators shall ensure:

- All work related injuries (including medical aid and lost time injuries) are promptly reported and recorded on the *Work Related Incident Record*. (Note this is in addition to the requirement for staff covered by WCB to report time loss injuries to the Worker's Compensation Board). Student injuries are still to be reported on *School Accident Report* and a copy forwarded to the Executive Assistant to Secretary-Treasurer.
- Copies of completed Work Related Incident Records are to be kept on file in a confidential area by a designated person at the worksite for at least **three** years; and
- Copies of the Work Related Incident Record is provided only to the injured person, government inspectors or individuals involved in medical treatment or the district health and safety program.

DEFINITIONS

Designated Area: Supplies and equipment must be kept in a place that is clean and accessible and where first aid services can be easily administered. This designated area could be a standalone room or simply the corner of an office.

Designated Person: An individual determined by the decision unit administrator is to be the keeper of the first aid records at the worksite.

Special Notes:

- Number of first aiders indicated is per shift at all times.
- The above requirements are the minimum requirements under OHS Act, Regulation and Code for low level hazard worksites.
- **Field trips** are to follow the same requirements dependent on the number of people. Considerations beyond minimum requirements should be given for field trips involving large groups, overnight stays or high risk activities. The use of fanny pack kits are recommended for field trips.
- Eyewash stations are to be easily accessible and marked for staff that comes in contact with potential eye injury hazards (cleaning, solvents etc.) During their day to day activities.
- Work Related Incident Records (WRIR) are to be accessible to staff and to be used as the legally required first aid records whenever first aid is administered.

- 3. 1-10 cm x 10 cm sterile compress dressing, with ties
- 4. 5- Antiseptic cleansing towelettes, individually packaged
- 5. 1- Cotton triangular bandage
- 6. 1- Biohazard waste disposal bag (single use)
- 7. 2- pairs Examination gloves. Disposable, medical grade, non-latex, powder free
- 8. 1- Adhesive tape 2.5 cm x 2.3 m (1 in x 2.5 yd)
- 9. 2- tubes Antibiotic Ointment, Topical single use
- 10. 1- roll Conforming stretch bandage, relaxed length, individually wrapped 5.1 cm x 1.8m
- 11. 4- hand/skin cleansing towelette, individually wrapped
- 12. 1- Splinter forceps/tweezers, fine point, stainless, min 11.4 cm

- 3. 3-10 cm x 10 cm sterile compress dressings, with ties
- 4. 3- 15 cm x 15 cm sterile compress dressings, with ties, individually packaged
- 5. 1-20 cm x 25 cm sterile abdominal dressing
- 6. 2- Conform gauze bandages- 75 mm wide
- 7. 4- Cotton triangular bandages
- 8. 1- Pair of scissors
- 9. 1- Splinter forceps/Pair of tweezers
- 10. 1- 25 mm x 4.5 m roll of adhesive tape
- 11. 2- Crepe tension bandages, individually wrapped- 75 mm wide
