	Board Chair M. Charlebois commenced the April 25, 2017 meeting at 4:13 pm.	
	Description	
III.	Presentation St. Jerome's School - Allan MacMillan	
	Enrollment has stayed consistent at around 372 students.	
	The school currently has 25 FTE teachers with approximately 20 support staff.	
	Technology – they have 2 iPad carts for Division 1 and 2, and they have 5 chrome book	
	carts that are very well used in the school.	
	All classrooms have a Juno system used for voice amplification and new microphones for the	
	 gym. Just over 1 in 4 students are coded or identified as in need of assistance at the school. 	
	 Student achievement, based on the Fraser report, indicates the school has dropped this year 	
	which they attribute to the coded students in the grade 6 class.	
	Trends that are occurring at St. Jerome's school include the high school continuing to	
	improve test results, while the elementary holds steady at high level. The Grade 6 results	
	 will continue to be influenced by the significant number of coded students in our system. Growth areas at St. Jerome's School include the level of excellence in Provincial 	
	 Growth areas at St. Jerome's School include the level of excellence in Provincial Achievement Tests and Diploma exams, increase parent involvement in school community, 	
	and course offerings not able to offer all of the courses.	
	Professional Development - continue to work on google drive, continue to develop CTF	
	programs at middle level. Developing strategies on successfully incorporating the increasing	
	numbers of special needs and English Language Learners into our school community.	
	 Develop capabilities in indigenous cultures and people and connections to curriculum. St. Jerome's has contacted someone from St. Paul to do a blanket ceremony with the Grade 	
	9 students.	
	Extra-curricular activities offered at St. Jerome's School include cross country, golf,	
	volleyball, basketball, curling badminton and track and field. Very active student leadership,	
	yearbook and Fall supper/carnival that raises quite a bit of money through fundraisers.	
	International Travel scheduled for Easter 2018.	
	High School retreats- the grade 10, 11 and 12 get their own retreats, they are 2-3 days with a	

- focus on spirituality, team and community building.
- The school raises money for multiple charities such as the food bank, Sister Gloria mission, Heart and Stroke, Diabetes, Terry Fox, Polio, and for the sport teams.
- The modernization of St. Jerome's School is mostly completed. The Principal is working with OML (contractor) and Alberta Infrastructure on deficiency issues.
- The School hired two new teachers this year, they may have seven teachers retire in the next three years, the challenge will be to build existing culture in new staff.
- Religious Education currently taking place at St. Jerome's School consists of prayer every morning, Mass on a monthly basis. Father Roger comes on a weekly basis to the school. They had special assemblies with Father Matthew Hysell when he delivered the Parish Lent Mission.

<u>Vermilion Outreach School – Derek Collins</u>

- Vermilion Outreach has moved to a new building located in downtown Vermilion.
- Vermilion Outreach is an alternative high school that provides students the opportunity to complete their diploma. They take students that are 15 years of age and older.
- They have started an adult program which is for students that are over the age of 19 but need to complete their high school diploma. The school is open one evening per week to help accommodate different needs.
- The Regular high school has a different program for each student.
- They currently have a teaching staff of 2.2 FTE.
- The Vermilion Outreach offers all high school courses, mandatory career exploration courses, a variety of CTS and Locally Developed Courses. They also offer programs through Lakeland College and the Dual Credit Program.
- Mentorship and community volunteerism is a big success in the school.
- They offer personal and academic counselling through the Family School Liaison (FSL) program. Two of the teachers are registered counsellors as well.
- They are averaging around 1300 CEUs per year.
- A large percentage of the student population is there to upgrade.
- Areas of strength for the school include students see them as a safe school, and the quality of education.
- Areas for growth for the school include the need to improve the perception of studies and continue to help students to prepare for diploma exams
- The school has an Induction program which is where the students learn about the school, begin career planning and begin experiencing success.
- Vermilion Outreach is a mentorship-partner with the Vermilion Elementary School.
- The students participate in community events such as assisting with the Santa Anonymous program.

- The Secretary-Treasurer is currently working on the budget.
- An increase in the ATA contract would be funded. There will be no increase for support staff this year and School of Hope enrollments are down.
- They are currently working on the online expense claim form and do not have a timeline for release.
- The division has rolled out the online leave request forms through SRB.
- They expect to test the online timesheets for the bus drivers and hourly support staff in May.
- There will be KEV training for secretaries on Thursday, April 27, 2017.
- · Submissions are now monthly and online.
- The Election package from Alberta Education is available online and training will be on May 2, 2017 in Edmonton.
- Christ-King School has a bus with over 300,000 Km on it. The division will need to replace the bus.
- The Secretary-Treasurer attended a zone meeting for ASBOA in April. The Professional Development was on electronic management.

- A survey was sent out to the teachers for Professional Development for the 2017/2018 school year. It appears teachers are reluctant to present at Professional Development days for the division.
- There was an online meeting of parent councils from School of Hope.
- The Assistant Superintendent attended the committee meeting for the Learning Network Support Staff Conference.
- The Assistant Superintendent and Trustee J. Sanson attended the meeting with the Archbishop on April 19, 2017.
- ACSTA will be hosting potential trustee workshops.
- The final Wellness meeting will be on April 28, 2017. The students are planning and facilitating the meeting.
- The division will receive \$141,000 from the government to implement a nutrition program in

the schools.

- The school administrators have been signed up for Catholic Leadership Conference in October 2017.
- The Superintendent attended a session called "Creating a Thriving Learning Community".
 They want to provide an Educational Assistant program in Wainwright that would be run through Lakeland College. We said that we would facilitate that by allowing them to use one of our facilities.
- A draft school calendar has been developed for next year.
- The Superintendent has met with School of Hope Administration team this week to discuss staffing for next year.
- School board elections are October 16, the division will have a trustee boot camp on October 20 prior to the organizational meeting. They will split it into two parts one session from ASBA and one from ACSTA.
- A Board Retreat has been scheduled for February 22, 23 and 24, 2018 to be held in Pigeon Lake. AB.
- Sent out notification of the two administrators' who were hired for Christ-King School and St. Thomas Aquinas School.
- Developing a new strategic plan.
