12. DIRECTOR OF TEACHING QUALITY AND STAFF DEVELOPMENT

The Director provided a report for the trustees to review. Sam Demma presentations have occurred at the schools and they have been well received. The students and parents have really enjoyed the presentations. The Director has been working on the Learning Disruption report. The results are good and the division has seen an improvement from September to June with the students that were tested. There is another application for the Learning Disruption funding that will come out soon. The division has received an extension for the Mental Health in Schools project. It was supposed to end in December but it has been extended to June 2025.
